

**BOND TO BE EXECUTED BY A SELECTED CANDIDATE WHILE

execute this Bond with such condition/s as hereunder is/are written:

NOW THE CONDITION OF THE ABOVE WRITTEN OBLIGATION IS THAT in the  
event of my failing to complete the study, or resigning or discontinue before completion of  
tenure of the course or otherwise quitting the course; and found guilty of any insubordination,  
interference or other misconduct or breach or non-performance or violation of any rules  
pertaining to the Institute and affiliating University; I shall forthwith pay to the Institute or as  
may be directed by the Director, LGBRIMH, Tezpur, Assam on demand the said sum of  
Rs.5,00,000/- (Rupees five lakh only).

AND upon my making such payment, the above written obligations shall be void and no  
effect, otherwise it shall be and remain in full force and virtue.

AND originals of all my certificates as mentioned below are submitted to the Department  
*and shall be retained till completion of the course:*

- b). Caste Certificate (if applicable)
- c). Admit Card issued by NBE
- d). Rank letter issued by NBE
- e). 12<sup>th</sup> Mark Sheet
- f). Mark sheets of MBBS/BDS 1<sup>st</sup>, 2<sup>nd</sup> and 3<sup>rd</sup> Professional Examinations
- g). MBBS Degree Certificate/Provisional Degree
- h). Permanent/Provisional Registration Certificate issued by MCI or DCI/State Medical  
or Dental Counsel. Provision Registration Certificate is acceptable only cases where

candidate is undergoing internship and likely to complete the same on or before 31<sup>st</sup> March of Year of admission.

i). Internship Completion Certificate from the Head of Institution or College that the candidate shall complete the Internship by **31<sup>st</sup> March, of the year of admission.**

j). Date of Birth Certificate.

k). Candidates allotted seat must carry one of the identification proofs (ID Proof) to the allotted college at the time of admission (as mentioned in the information bulletin published by the National Board of Examination (NBE) for AIPGMEE i.e. PAN Card, Driving License, Voter ID Card, Passport or Aadhar card).

The Bond shall in all respects be governed by the laws of India for the time being in force and the rights and liabilities hereunder shall, where necessary, be accordingly determined by the appropriate Courts in India under Jurisdiction of Tezpur District Court, District: Sonitpur (Assam).
