INTRODUCTION

Lokopriya Gopinath Bordoloi Regional Institute of Mental Health (LGBRIMH) is a premier Mental Health Institute in Northeast India. The Institution was established in the year 1876 and is recognized as one of the oldest centers providing quality mental health care treatment and training in mental health.

The Institute is mandated to be a tertiary care institute of Mental Health & Neurosciences and it is under the administrative control of the Ministry of Health & Family Welfare, Govt. of India.

Regular academic course in the Institute started in the year 2001 with the introduction of one year Diploma in Psychiatric Nursing (DPN). The DNB in Psychiatry was started in the year 2006. This was followed by the M. Sc Nursing (Psychiatric Nursing) in 2007; M. Phil in Psychiatric Social Work in 2009, M.D (Psychiatry) in 2010 and the M. Phil in Medical and Social Psychology started in 2011 was later renamed as M. Phil in Clinical Psychology from 2014. The Ph.D. programme in Psychiatric Social Work (PSW) and Psychiatric Nursing was started in October 2017 with an intake of 3 (three) and 2 (two) respectively. Master in Medical Laboratory Sciences (MMLS) in Department of Clinical Biochemistry, Hematology & Blood Banking and Medical Microbiology is being introduced from the current session. The courses offered by the institute are affiliated to Gauhati University and are recognized by Medical Counseling Committee / Rehabilitation Council of India / Indian Nursing Council. The courses are designed to serve the specific needs of the country in general and the Northeastern region in particular to develop the manpower requirement in the field of mental health. The DNB course has been discontinued from the year 2014.

The Institute provides patient care services by a multidisciplinary team of mental health professionals with the basic objective of providing equitable access to quality psychiatric care to all sections of the society and thus reducing the global burden of diseases. It also takes numerous initiatives for promotion of positive mental health in the country and reduce the stigma and prejudice associated in this field.

RESERVATION OF SEATS FOR ALL COURSES

Reservation as per Government rules will be followed. All the claims for reservation must be as per the prescribed format given at the Annexures.

15%, 7 ½%, 27% and 10 % seats are reserved for Scheduled Castes, Scheduled Tribes, Other Backward Classes (Non-creamy layer) and Economically Weaker Section (EWS), respectively, subject to availability of such candidates, and with evidence of the claim.

There shall also be 5% horizontal reservation for persons with locomotor disability [only for locomotor disabilities of lower limbs between 50% to 70% or as per the Govt. of India Rules in this regard] subject to availability of such candidates.

Applicants who are seeking reservation benefit in the OBC category should submit a certificate as per DOPT O.M. No. 36033/1/2013-Estt. (Res) dated 13th September 2017.

The issuing date of OBC (NCL) certificate must not be older than a year up to the closing date for submission of online application form.

Applicants who are seeking reservation benefit in the EWS category should submit a certificate as per DOPT O.M. No 36039/1/2019-Esst(Res) dated 31/01/2019.

STIPEND

Stipend per month for non-deputed applicants will be as per institute rules. Applicants who are on deputation will not be paid any stipend from the Institute. Applicants claiming seat based on JRF or other fellowships, are not eligible for Institute stipend.

BOND AGREEMENT

All the selected applicants will have to submit a respective Bond Agreement attached in the prospectus on joining the course.

The bond provisions will be applicable for all institute stipendiary and other external fellowship holders (example JRF).

SCHEME OF EXAMINATION

The examination for various courses will be held as per the guidelines of Gauhati University /Medical Counseling Committee/Indian Nursing Council/Rehabilitation Council of India/ the Assam Nurses' Midwives' & Health Visitors' Council.

In addition to the above, Enrolment fees, Eligibility Fees, Registration Fees, Examination Fees, monthly Supervisory Fees (PhD) and any other fees as mandated by the university/council have to be paid to the affiliating University / State Nursing Council from *time to time* as per norms after admission.

DISCONTINUATION OF STUDIES

A) Conditions for Leaving the Course

The trainee has to abide by the conditions of **Bond Agreement** and pay the penalty amount in the event of discontinuation of the course after final admission through NEET PG counseling for MD Psychiatry course.

Compliance to the Bond Agreement is applicable for the MSc, MPhil and PhD courses.

B) Disqualification from Continuing the Course

The trainee will be declared disqualified from continuing the course under the following circumstances –

- i. Any form of misconduct with any patient/patient relative/faculty member / staff.
- ii. If disqualification is suggested by a disciplinary committee.

- iii. If the trainee does not appear in the examination for 03(Three) consecutive times.
- iv. Submission of false documents or concealing related information.
- v. If the trainee does not follow the rules and regulations of the Institute and concerned regulating bodies.
- vi. Trainee once expelled from the Institute will be disqualified to appear in any examination in LGBRIMH in the future.
- vii. The matter of absence for more than one month will be dealt as per institute norms.

LEAVE MATTERS

- All leave must be pre-sanctioned.
- Trainees must inform the respective Head /I/c of the Departments about their leave.
- M.D. students: First Year: 30 days and Second and Third Year 36 days in a completed academic year (As per residency scheme adopted by the institute)
- M. Sc./Ph.D. Nursing (Psychiatric Nursing), Masters in Medical Laboratory Sciences (MMLS), M. Phil/Ph.D. in Psychiatric Social Work and M. Phil/Ph.D in Clinical Psychology: As per institute norms.

DATE OF JOINING

Selected applicants must join the course, after paying the necessary fees on or before the stipulated dates, failing which the selection shall automatically stand cancelled. The institute shall offer such seats to the applicants in the waiting list in order of merit.

SUBMISSION OF AFFIDAVIT ON RAGGING

Ragging is totally prohibited at LGBRIMH, and anyone found guilty of ragging and/or abetting ragging, is liable to be punished as per norms. All the trainee/students have to register for anti-ragging affidavit on prescribed anti ragging App provided by MHRD (UGC anti ragging cell). To download / install App, please visit website of the Institute (www.lgbrimh.gov.in / <https://www.lgbrimh.gov.in/antiragging.html>) (under 'importance Links – bottom of home page) or Google play store Anti ragging/ MHRD App. The affidavit/ acknowledgement produced after registering with the app is to be submitted on admission duly signed by the trainee and guardian.

A trainee seeking admission to a Hostel shall have to submit additional affidavits on the date of Hostel Admission.

GENERAL INSTRUCTIONS

1. **The Admission-cum-Counseling Committee (ACC) will look after the requirements of admission and counseling, on declaration of GU Entrance Examination (PG-MSc) & GU-RET (MPhil & PhD) results by Gauhati University.**
2. **The applicants are advised to visit the LGBRIMH website (www.lgbrimh.gov.in) and the GU portal, from time to time, for relevant information and instructions. (<https://admissions.guportal.in>),(<https://admissions.gauhati.ac.in/phd/guret>).**
3. **Applicants must submit downloaded online application form on the date of counseling for verification which has already been submitted to Gauhati University.**
4. **Applicants must produce GU-RET-2020 Admit Card on the date of counseling for verification.**
5. **Applicants must produce all certificates and mark sheets including caste/ class/ tribe and experience certificate in original on the day of counseling for verification. OBC (NCL) certificate should be as per Central Govt. format. On failure to do so, their candidatures shall be rejected straightway without further opportunity and notice, and seats shall be allotted to the next available/eligible candidates.**
6. **High School/ Higher Secondary Certificate/ Birth Certificate as proof of date of birth.**
7. **All documents must be in English or an equivalent translation made available, documents are in other languages.**
8. **Employees of the State or Central Government or any public undertaking organization should produce a **NO OBJECTION CERTIFICATE** from the employer at the time of counseling or as stipulated.**
9. **The cut-off date for determining the eligibility criteria for admission is the closing date for submission of online application form.**
10. **The decision of the Admission-cum-Counseling Committee shall be final in the matters of the selection of candidates.**
11. **The period of training/course of study is full-time. Applicants are strictly prohibited from undergoing any other part-time or correspondence course during the period of training/ course of study.**
12. **All applicants admitted to the Institute shall maintain good conduct, follow pandemic related advisory, attend to their clinical work, academics and research regularly and abide by the rules and regulations of the Institute/Hostel.**
13. **Selected applicants shall have to submit the Migration Certificate and Transfer certificate from the Board/University from which they have passed the last qualifying examination at the time of admission/joining the course.**

14. Applicants allotted seat must carry one of the identification proofs (ID Proof) to the Institute at the time of admission i.e. PAN Card, Driving License, Voter ID Card, Passport or Aadhar card etc. for needful information.
15. On request, hostel accommodation will be provided to the admitted students subject to availability of seats. Students have to follow hostel rules and regulations apart from paying the requisite dues.
After completion of the course, students/trainee will have to vacate the hostel room within 7 days. Failing which, penal license fee will be charged ten times the rate of normal license fee.
16. **The Admission cum Counseling Committee will take into consideration anything not specified herein, in regard to the admission process.**

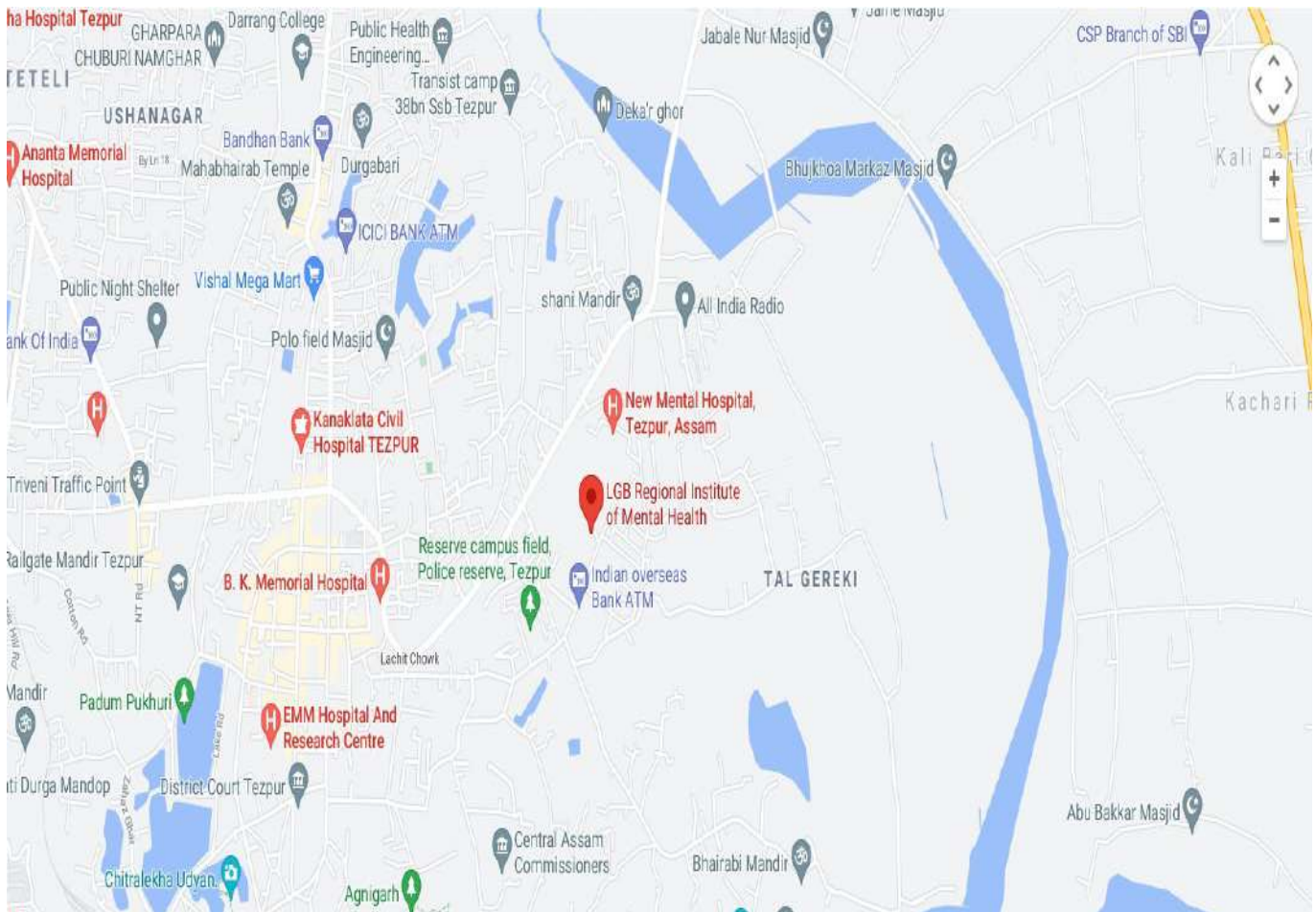
