Admission into MD, Psychiatry at LGBRIMH (All India quota & NE States sponsored candidates)

This is for information of all the selected candidates for MD, Psychiatry course at LGBRIMH have to bring the following **documents** in original for admission as per MCC notification:

- i. Allotment Letter issued by MCC (Essential document)
- ii. Admit Card issued by NBE
- iii. Result/Rank Letter issued by NBE
- iv. Mark Sheets of MBBS/BDS 1st, 2nd & 3rd Professional Examinations.
- v. MBBS/BDS Degree Certificate/Provisional Certificate. (Essential document)
- vi. Internship Completion Certificate/Certificate from the Head of Institution or College that the candidate shall complete the Internship by 31st March, of the year of admission.
- vii. Permanent / provisional Registration Certificate issued by MCI/NMC or DCI/State Medical or Dental Council. Provisional Registration Certificate is acceptable only in cases where candidate is undergoing internship and likely to complete the same on or before 31st March of the year of admission. (Essential document)
- viii. High School/Higher Secondary Certificate/Birth Certificate as proof of date or birth.
- ix. Class 12 mark sheet
- x. Candidates allotted seat must carry one of the identification proofs (ID Proof) to the allotted college at the time of admission (as mentioned in the information Bulletin published by the National Board of Examinations (NBE) for NEET i.e. PAN Card, Driving License, Voter ID, Passport or Aadhaar Card).
- xi. The Candidate should also bring the following certificates, if applicable:
 - a) SC/ST Certificate issued by the competent authority (in the format as specified in the Information Bulletin) and should be in English or Hindi language. Sub caste should be clearly mentioned in the certificate. The translated certificate must be certified by a Gazetted Officer. (Essential document)
 - b) EWS Certificate as per the Central Govt. Norms (in the format as specified in the Information Bulletin) and should be in English or Hindi language. The translated certificate must be certified by a Gazetted Officer. (Essential document)
 - c) OBC certificate issued by the competent authority. The sub-caste should tally with the Central List of OBC. The OBC candidates should not belong to Creamy Layer. The OBC certificate must be in the format as mentioned in the prospectus. The translated certificate must be certified by a Gazetted Officer. (Essential document)
 - d) Disability Certificate issued from a duly constituted and authorized Medical Board for 21 Benchmark Disabilities as per the Rights of Persons with Disability Act, 2016 and NMC

Norms. No other PwD certificate, issued by any other Authorities/ Hospital will be entertained. The format of Certificate of Disability is annexed in the Information Bulletin. (Essential document).

2. In accordance with the minimum qualifying/eligibility criteria for admission to MD/MS/PG Diploma course as mentioned in the information Bulletin for NEET-PG 2022, the cut-off scores for various categories are as follows:-

Category	Minimum Qualifying/Eligibility Criteria	Cut-off Score (out of 800)
General / EWS	50 th Percentile	275
SC / ST/ OBC (including PWD of SC/ST/OBC)	40 th Percentile	245
UR PWD	45 th Percentile	260

3. Each and every question in NEET-PG 2022 was reviewed by the faculty members from the concerned specialty after the conduct of NEET-PG 2022 to re-check for technical correctness of the questions as well as answer keys. As per inputs from the faculty members, two questions were found to be technically incorrect / have more than 1 correct option in the Question paper of NEET-PG 2022. Full marks have been awarded to all the candidates who appeared in the exam for these questions, irrespective of the fact whether these two questions have been attempted or not attempted by the candidates.
4. As per the counselling policy of MCC, a candidate can choose the benefit of only one kind of reservation. Accordingly, candidates choosing their Nationality as NRI/Foreign Nationals/OCI or PIO shall not be entitled to avail any benefits of SC/ST/OBC/EWS/PwD, in the counselling conducted by MCC and also in the qualifying criteria of NEET-PG 2022.
