Details of terms & conditions for Contractual Appointment for the above mentioned posts as under

### Terms & Conditions For Contract Appointment

- 1. If the contract is not extended further, the same will lapse automatically. The appointment may be terminated at any time, giving one month's notice or by paying one month's salary by the appointee or failure to complete the period of three months to the satisfaction of competent authority. However, the Competent Authority reserves the right to terminate forthwith without assisgning any reason thereof.
- 2. The appointee shall perform the duties as assigned to him/her. The competent authority reserves the right to assign any duty as and when required. No extra/additional allowances will be admissible in case of such assignment.
- 3. The appointee shall not be entitled to any other benefits like Provident Fund, Pension, Gratuity, Medical Attendance Treatment, Seniority, Promotion etc. or any other benefits available to the Government Servants, appointed on regular basis.

- 5. The appointee shall be on the whole time appointment of the LGBRIMH and shall not accept any other assignment, paid or otherwise and shall not engage himself/herself in a private practice of any kind during the period of contract.
