Essential Qualification for Sl. No. 1 to 3:- (i) A recognized medical qualification included in the First or the Second Schedule or Part II of the Third Schedule (Other than Licentiate Qualification) to the IMC Act, 1956. Holders of educational qualifications included in part II of the Third Schedule should also fulfill the conditions stipulated in sub-section (3) of Section 13 of IMC Act 1956. (ii) Post graduate degree in the concerned speciality mentioned in section A of Schedule-VI or equivalent.

Essential Experience for Professor (Sl. No. 1) – 12 years standing in the Profession out of which at least 4 years' experience should be in the concerned specialty as Associate Professor in a Medical College/ Teaching Institution after the requisite post-graduate degree qualification. Extensive practical and administrative experience.

Essential Experience for Associate Professor (Sl. No.2)- At least five years' experience as Tutor/Demonstrator Sr. Resident/ Registrar/Lecturer in the concerned specialty in a recognized

teaching institution after the requisite post-graduate degree qualification out of which at least 2 years shall be as Assistant Professor.

Essential Experience for Assistant Professor (Sl. No.3)- At least three years' experience as Lecturer/Tutor/Registrar/Demonstrator Sr. Resident in the concerned specialty in a recognized teaching institution after the requisite post-graduate degree qualification

Non- Medical Posts

Essential Qualification for (Sl. No. 4 to 9): (i) Master's degree in Clinical Psychology/Social Work/Psychiatric Nursing. (ii) Recognized M. Phil degree for Clinical Psychology/Psychiatric Social Work. (iii) Ph.D. in Clinical Psychology/PSW/Psychiatric Nursing from a recognized Institutions / University

Essential Experience for Associate Professor (Sl. 4 to 6): At least five years of teaching/research experience out of which two years as Assistant Professor.

Essential Qualification for Sl. No. 10: Master's degree in concerned discipline with 55% marks from a recognized University or institute. Master of Philosophy (2 years course) in the concerned discipline from a recognized University or institute. Two years' post M. Phil teaching and research experience in a Mental Hospital, Child Guidance Clinic or Psychiatric Department of a General Hospital/recognized teaching institution.

Essential Qualification for Sl. No. 11: Master's degree in concerned discipline with 55% marks from a recognized University or institute. Master of Philosophy (2 years course) in the concerned discipline from a recognized University or institute. Two years' post M. Phil teaching and research experience in a Mental Hospital, Child Guidance Clinic or Psychiatric Department of a General Hospital/recognized teaching institution.

Essential Qualification: For Sl. No.12. Master's Degree in Psychiatric Nursing with at least 55% marks from a recognized University/ Institution. Registered as Nurse and Midwife with Central or State Nursing Council. **Desirable:** 2 years post M.Sc. teaching and research experience in a mental hospital or psychiatric department or a general hospital/ recognized teaching institution. Research/published work in indexed journals.

Details of terms & conditions for Contractual Appointment for the above mentioned posts as under

Terms & Conditions For Contract Appointment

1. The appointment is purely on CONTRACT BASIS for a period of 03 months with effect from the date of joining which may be further extended as per functional requirement of the Institute; or till such time the regular arrangements are being made, whichever is earlier. If the contract is not extended further, the same will lapse automatically. The appointment may be terminated at any time, giving one month's notice or by paying one month's salary by the appointee or failure to complete the period of three months to the satisfaction of competent authority. However, the Competent Authority reserves the right to terminate forthwith without assigning any reason thereof.

2. The appointee shall perform the duties as assigned to him/her. The competent authority reserves the right to assign any duty as and when required. No extra/additional allowances will be admissible in case of such assignment.
3. The appointee shall not be entitled to any other benefits like Provident Fund, Pension, Gratuity, Medical Attendance Treatment, Seniority, Promotion etc. or any other benefits available to the Government Servants, appointed on regular basis.
4. The appointee shall not have any claim or rights for regular appointment to any post at LGBRIMH.
5. The appointee shall be on the whole time appointment of the LGBRIMH and shall not accept any other assignment, paid or otherwise and shall not engage himself/herself in a private practice of any kind during the period of contract.
6. On appointment, the appointee will be required to take an Oath of Allegiance to the Constitution of India or make a solemn affirmation to that effect in the prescribed proforma. Also, they will have to sign on Deed of Agreement.
7. Other conditions of service will be governed by relevant rules and orders issued from time to time.
8. If any declaration given or information furnished by him/her proves to be false or if he /she is found to have wilfully suppressed any material, information, he/she will be liable for removal from service and also such other action as the Government may deem necessary.
9. If any candidate is found canvassing for his/her selection, he/she will be disqualified for being selected.
