Essential Qualification for Sl. 01: (i) I or II class Master's Degree in Psychology (ii) M.Phil in Clinical Psychology or equivalent qualification from a recognized Institution. (iii) Ph. D in Clinical Psychology from a recognized Institution/ University.

Essential Experience for (Sl. 01): i) 12 years standing in profession with teaching & research experience out of which 4 years as Associate Professor in the concerned discipline.

Essential Qualification for Sl. 2 & 3 : (i) A recognized MBBS degree qualification included in the First or Second Schedule or Part-II or the Third Schedule (other than licentiate qualifications) to the Indian Medical Council Act, 1956(102 of 1956). Holders of educational qualifications included in Part-II of the Third Schedule should also fulfill the conditions specified in sub-section (3) of section 13 of the Indian Medical Council Act, 1956(102 of 1956). (ii) Post-graduate degree in the concerned speciality mentioned in Section –A of Schedule-VI or equivalent recognized DNB qualification awarded by National Board of Examination.

Essential Experience for Sl. 2 & 3: At least five years teaching experience as Senior Resident/ Demonstrator/Registrar/ Assistant Professor or Lecturer in the concerned Specialty or Super-speciality in a recognized teaching institution after obtaining the first post graduate degree out of which at least two years shall be as an Assistant Professor.

Essential Experience for Sl. No. 4: (i) At least 5 years teaching & research experience in Psychiatric Nursing out of which 2 years as Assistant Professor in a recognized Institute.

(ii) Post-graduate degree in the concerned speciality or Super speciality mentioned in Section –A of Schedule-VI or equivalent recognized DNB qualification awarded by National Board of Examination.

Essential Experience for Sl. No. 5 to 7: (Super Speciality and other than Superspecialty): At least three years teaching experience as Senior Resident/ Demonstrator/Registrar/ Lecturer in the concerned Specialty or Super-speciality in a recognized teaching institution after obtaining the first post graduate degree.

Essential Qualification for Sl.No. 8 & 9: (i) Master's Degree in Social Work /Psychology (ii) M.Phil in Psychiatric Social Work/Clinical Psychology or equivalent qualification. from a recognized Institution. (iii)Ph. D in Psychiatric Social Work/Clinical Psychology from a recognized Institution/ University.

Essential Experience for Sl.No. 8 & 9 : 3 years teaching /clinical /research experience in the concerned subject after Ph.D degree.

Essential Qualification for Sl. No. 10: (i) Master's Degree in Psychiatric Nursing (ii) Ph. D in Psychiatric Nursing from a recognized Institution/ University.

Essential Experience for Sl. No. 10: 3 years teaching /clinical /research experience in the concerned subject after Ph.D degree.

Essential Qualification for Sl. No. 11: (i) Master's Degree in statistics or Mathematics with Statistics as additional subject or allied subject. (ii)PhD in Biostatistics or any equivalent from a recognized university. (iii) 2 years' experience of data processing and statistical work in any Institution/ University preferably in a medical college/ Institution.

Note 1 :- Doctorate of Medicine (DM) or Magister Chirurgiae (M. Ch.) qualification of three years' duration shall be counted towards requirement of teaching experience.

Note 2 :- Doctorate of Medicine (D.M.) or Magister Chirurgiae (M.Ch.) qualification of five years' duration, shall be taken as three years for completion of post graduate degree and the last two years of the said Doctorate of Medicine (D.M.) or Magister Chirurgiae (M.Ch.) shall be counted towards requirement of teaching experience.

Note 3: Teaching experience in any other post like the post of General Duty Medical Officer shall not be considered for eligibility purpose for recruitment to teaching posts.

Note 4: For Sl. No. 5 candidates having super specialty degree in Geriatric mental health/child & adolescent Psychiatry will be preferred.
