**Essential Qualification For (Sl. No. 1 to 3):** (i) A recognized MBBS degree qualification included in the First or Second Schedule or Part-II or the Third Schedule (other than licentiate qualifications) to the Indian Medical Council Act, 1956(102 of 1956). Holders of educational qualifications included in Part-II of the Third Schedule should also fulfill the conditions specified in sub-section (3) of section 13 of the Indian Medical Council Act, 1956(102 of 1956). (ii) Post-graduate degree in the concerned speciality or Super speciality mentioned in Section –A of Schedule-VI or equivalent recognized DNB qualification awarded by National Board of Examination.

**Essential Experience for Assistant Professor (Super Speciality and other than Superspecialty):**

At least three years teaching experience as Senior Resident/ Demonstrator/Registrar/ Assistant Professor or Lecturer in the concerned Specialty or Super-speciality in a recognized teaching institution after obtaining the first post graduate degree.

**Note 1.-** Doctorate of Medicine (DM) or Magister Chirurgiae (M. Ch.) qualification of three years' duration shall be counted towards requirement of teaching experience.

**Essential Qualification:** ( i) Master's Degree in Psychiatric Nursing (ii) Ph. D /D.Sc. in Psychiatric Nursing from a recognized Institution/ University.

**Essential Experience:** 3 years teaching /clinical /research experience in the concerned subject after Ph.D degree.

**GENERAL CONDITIONS**

1. Candidates who do not fulfill requirements as per advertisement need not apply.
2. All Medical Qualifications should be recognized under MCI/NMC.
3. Allowances will be as per Central Government rates as adopted by this Institute from time to time and NPA will be admissible in case of Medical Posts only.
4. Candidates working in State/Central Govt./PSU/Autonomous Body must apply through proper channel or submit "No objection certificate" from current employer.
5. Relaxation in upper age limit will be applicable in case of SC / ST / OBC / EWS candidates as per the Central Government norms.
6. Candidates applying under any reserved category post, viz.SC/ST/OBC/ / EWS will be considered subject to caste/PwBD certificate issued by the appropriate/ Competent Authority on the prescribed format. Community should be clearly and legally mentioned in the certificate.
7. Reservation for Economically Weaker Sections (EWSs) shall be applicable as per Govt. of India, Office memorandum No.36039/1/2019-Estt(Res)DoPT dated 19<sup>th</sup> January,2019 and 31<sup>st</sup> Januray,2019, EWS candidate must ensure that they have a valid EWS certificate on the last date of submission of application issued by the competent authority. In case suitable Economically Weaker Sections(EWSs) candidates are not found, these posts will not be carried forward/or considered as backlog vacancy, hence Unreserved (UR) candidates may also be allowed provisionally to apply against EWSs post advertised through above referred advertisement who may be considered in case EWSs candidate are not found to fill up these posts reserved for EWSs.

8. Reservation will be as per Government of India Policy.
9. Applicants applying for the posts reserved for OBC must obtain certificate of OBC (non-creamy layer) in the prescribed form issued by Competent Authority. The certificate should be of the current financial year, in accordance with instructions issued by the Government of India in this respect from time to time. Applicants should ascertain that they belong to the reserved categories (caste) enlisted in the central List for the Other Backward Classes. OBC candidate(s) should not belong to Creamy Layer and their sub-caste should match with the entries in Central List of OBC, failing which their candidates will not be considered under any of the applied reserved category post(s).
10. Appointments in case of direct recruitment will be on probation for 2 (two) years.
