Essential Qualification for the post of Speech Therapist Sl. No. 2: i) B.Sc. (Hons) in Speech Pathology & Audiology or equivalent qualification from a recognized University / Institutions. **Desirable:** 2-3 years working experience in the field of Speech Pathology preferably in Neuro – psychiatric disorder in a psychiatric hospital of Central / State / Semi Govt. organization.
