**Essential Qualifications and experience for the post of Publication Assistant:** Bachelor's Degree in any discipline from a recognized University with at least 3 years experience in proof reading of technical literature/science journals in a reputed publishing house. **Desirable:** Proficiency in English language. Knowledge of production aspects of science publication. Diploma in Journalism/Printing.

**GENERAL CONDITIONS**

1. Candidates who do not fulfill requirements as per advertisement need not apply.
