1.	<p><u>Process of submission of online bid:</u></p> <p>The bidders are requested to submit the soft copies of their bid electronically on the CPP portal using valid Digital Signatures (DSC).</p> <ol style="list-style-type: none"> a) Bidders are required to enroll on the e-Procurement module of the Central Public Procurement Portal (http://eprocure.gov.in/cppp). b) The bidders will be required to choose a unique username and assign a password for their accounts and are advised to register their valid email address and mobile numbers as part of the registration process. c) Upon enrolment, the bidders will be required to register their valid Digital Signature Certificate (Class II or Class III Certificates with signing key usage) issued by any Certifying Authority recognized by CCA India with their profile. Only one valid DSC should be registered by a bidder. d) Bidder then logs in to the site through the secured log-in by entering their user ID / password and the password of the DSC / e-Token. e) Bidder should take into account any corrigendum published on the tender document before finally submitting their bids in the CPP portal (http://eprocure.gov.in/cpp). f) Please note the number of covers in which the bid documents have to be submitted, the number of documents - including the names and content of each of the document that need to be submitted. 3.	<p><u>EMD/ PERFORMANCE SECURITY</u></p> <ol style="list-style-type: none"> a) Bidder should submit EMD Rs. 60,000.00 in the form of DD/FDR/BG drawn in favor of Director, LGBRIMH, Tezpur, Assam payable at Tezpur, failing which the tender shall not be

considered for acceptance and will be summarily rejected. Cash, Cheque or any other mode of payment will not be accepted at all. The EMD deposited against previous tender cannot be adjusted or considered for this tender. No interest will be payable on the EMD/BID security. The EMD of the successful bidder will be released only after the concerned firm deposits necessary performance security. **The DD/FDR/BG of EMD should reach LGBRIMH before the last date of opening of technical bid.**

- b) Performance Security, equivalent to 5% of the total cost of the items approved shall have to be deposited by the successful bidder through DD/FDR/BG/Insurance Surety Bonds drawn in favour of Director LGBRIMH, payable at Tezpur. Performance security should remain valid for a period of 14 month from the date of Award of contract. The same amount will be released after fulfillment of contractual obligations and no interest shall be payable thereof.
- c) Tender Number, its due date and complete address of the firm should also be clearly written on the **BACK SIDE OF THE DEMAND DRAFT SO AS TO ENSURE** safe return of the demand draft to the unsuccessful or successful tenders as the case may be.
- d) EMD of unsuccessful bidders will be returned in due time.

4. **SIGNING OF BID:-**

- a) The bid is liable to be ignored if incomplete information is given or documents asked for are not dully filled or furnished.
- b) Individual signing the bid or other documents concerned with the bid must specify whether he signed as :
 - i) A sole proprietor of the firm, or constituted Attorney of such proprietor.
 - ii) A partner of the firm, if it is a partnership concern, in which case, he must have legal authority to sign, answer and admit to refer dispute to arbitration.
 - iii) Constituted Attorney if it is a company.

NOTE:-

** In case of (b)ii, a copy of the Partnership Deed, General Power of Attorney, in each case, duly attested by a Notary Public, as affidavit on a stamp paper to the effect that all the partners admit execution of the partnership agreement and authority of the general power of attorney should be furnished.

** In case of partnership firm, where no authority to refer disputes concerning the business or the partnership has been conferred on any such partner, the bid and all other related documents must be signed by every partner of the firm.

** A person signing the bid form or any documents forming part of the bid on behalf of another shall be deemed under warranty that he has the authority to bind himself with such person. If on enquiry, it appears that the person so signing has no authority to do so, the purchaser without prejudice to other Civil & Criminal remedies can cancel the contract and hold the signatory responsible for all cost & conveyances arising there from.

TERMS OF SUPPLY :-

- 5.
- i. **Liability for late Supply & Non supply:-** If the vendor fails to supply the goods (partly or whole) within the time as per supply order, a sum equivalent to 0.5 percent of the order value for each week of delay up to the extended period will be deducted from the security deposit as liquidated damages (subject to maximum deduction of 5 (Five) % percent of the order value) and if the security money deposits are not sufficient, action may be taken to realize the loss as per the law of the land.
 - b) **Supply of goods should be completed within the time as per supply order; in case of urgency of item deliveries may be completed within 2-3 days.**
 - i. In case the supplier fails to supply the goods (partly or whole) within the stipulated time as indicated in the supply order, the supply order lying with the supplier will stand automatically cancelled and LGBRIMH shall be at liberty to get the goods supplied from other available sources at the cost of the defaulting supplier. The additional expenditure so incurred for getting the goods shall be borne by the defaulting supplier in addition to forfeiture of security money deposit and if he fails to compensate the entire loss and if the security money deposits are not sufficient, action may be taken to realize the loss as per the law of the land.
 - ii. If the bidder fails to supply any stocks as per terms and conditions of acceptance of tender or fails to replace any stock rejected by the direct demanding officer within a period as stipulated by the institute or any person authorized by the institute on his behalf, the institute is **entitled to purchase such stock /partial stocks from any other source at such price or at market price without notice to the contractor.** The additional expenditure so incurred for getting the goods shall be borne by the defaulting supplier in addition to forfeiture of security money deposit and if he fails to compensate the entire loss and if the security money deposits are not sufficient, action may be taken to realize the loss as per law of the land. **The quantity of stock/partial stocks if purchased will automatically stand canceled from the order.**
 - c) It will be the responsibility of the bidder for safe transport of goods to the destination address i.e., LGBRIMH, Tezpur.
 - d) **No payment shall be made for any rejected material.** The bidders would remove the rejected items within two weeks of the date of rejection at their own cost by replacement immediately. In case these are not removed, these will be disposed off in manner as deemed fit by the authorities at the risk and responsibility of the supplier without any further notice.
 - e) Extension of delivery period in exceptional case will be entirely at the discretion of the Director, LGBRIMH.
 - f) The supplier will be liable to present bill after completion of indented supply.

RIGHT OF ACCEPTANCE :-

- a) Director, LGBRIMH, reserves the right to reject/accept any or all tenders without assigning any reasons thereof and also have the right to place order on one or more firms. No correspondence will be entertained.
- b) The quantity shown in the Annexure-I is approximate, which may be increased or decreased to an extent depending upon the actual requirement.
- c) Bidders should not quote rates more than MRP. In case any bidder quote higher rates than MRP, the action will be taken as deemed fit by the Director, LGBRIMH including removal of the name from the bidder list.
- d) The medicines/ drugs/ stores to be supplied will be of standard quality. In case it is found that any particular medicine's date is expired and found not of standard quality, substandard or spurious, supplier will be liable to be blacklisted for a period of five years besides other legal action that may be initiated .In case the suppliers fail to supply indented drugs / medicines or other items within the stipulated time, the institute will procure the same from open market and the supplier will be liable to pay the liquidated damage which will be recovered from bills or security deposit or as the case may be.
- e) If the bidder gives false statement on any of the above information, the firm / supplier will not be considered and their tender shall be deemed to be rejected and the security deposited will be forfeited.
- f) It will be prerogative of the institute to place the supply order for the whole lot / item or in piecemeal basis depending upon the requirement of the institute.
- g) The store offered should comply with the provision of the Drugs and Cosmetics Act-1940 and the rules made thereafter and as amended from time to time.

7.	<p><u>SAMPLE TESTING :</u></p> <p>a) The medicines / drugs supplied may be tested by the authorized chemical analyst. If at any stage of the use the supplies are found substandard, NO PAYMENT will be made for the entire rejected / substandard batch of that particular items , even if the supplies have been consumed in good faith and the facts will be notified to the Drugs controller of India / State drug controller for taking necessary action and with his permission only the firm will be asked to remove the remaining supplies of substandard items and no further stores of that particular items will be purchased till clearance is obtained from the state / central drug controller , and the appropriate amount of intended drugs along with penalty will be imposed by the authority.</p> <p>b) The institute reserves the right to conduct its own quality control/ sample testing at any time with or without information of the supplier. If at any stage the uses of the supplies are found to be substandard actions as per Para 7(a) will be taken.</p>
8.	<p>Un-utilized goods will be notified by this office three months prior to its expiry and the same should be replaced free of cost.</p>
9.	<p><u>METHOD OF SUPPLY :-</u></p> <p>a) Every medicine should have its own shelf life period mentioned on the label of medicines calculated from the date of manufacture. The life of the medicines supplied should have minimum of one year life period at the time of receipt at LGBRIMH.</p> <p>b) All containers i.e. bottles , tins, cartoons, tubes, etc are required to be secured with pilfer proof packing so as to ensure genuineness of the product packed and correctness of its contents and shall be neatly labeled.</p> <p>c) The medicines/ drugs/ stores to be supplied will be of standard quality. In case it is found that any particular medicines date is expired or found not to be of standard quality, sub standard or spurious, the supplier will be liable to be blacklisted for a period of five years besides other legal action that may be initiated.</p> <p>d) It may be confirmed that the prices quoted are not in excess of Drug Price Control Order 1970, and the rules made thereafter and as amended from time to time.</p>
