Terms and Conditions:

1. The engagement is offered on a **full-time contract basis for a fixed term of one (1) year**, effective from the date of joining. This term is contingent upon the continued availability of funds under the scheme; the contract shall expire upon the completion of one year or the cessation of funding, whichever is earlier. Renewal is discretionary and subject to the provisions of the ATF Scheme. If not renewed, the contract shall expire automatically. The contract may be terminated by either party upon serving a one-month notice period or by remitting a sum equivalent to one month's salary. Notwithstanding the above, the Competent Authority retains the absolute right to terminate the engagement immediately, without prior notice or cause, at any stage of the tenure.
2. The appointee shall not have any claim or rights for regular appointment to any post at LGBRIMH.
3. The appointee will carry out the duties assigned to them, with the competent authority holding the discretion to assign additional tasks as needed. No extra allowances will be provided for such assignments.
4. The appointee shall not be entitled to any other benefits like Provident Fund, Pension Gratuity, Medical Attendance Treatment, Seniority,

- Promotion etc. or any other benefits available to the Government Servants, appointed on regular basis.
5. Prescribed qualification is minimum and mere possessing does not entitle any candidate for selection.
 6. Decision of Selection Committee at LGBRIMH, Tezpur regarding selection of candidates will be final and no representation in any manner will be entertained in this regard.
 7. No travelling or other allowances will be paid to candidate for interview/joining for the post.
 8. Work and conduct will be reviewed from time to time and if not found satisfactory/suitable, shall be terminated immediately without any notice.
 9. Candidate is expected to conform to rules of conduct and discipline as applicable to institute employees.
 10. Candidate should not have been convicted by any Court of Law.
 11. No other allowance/facilities other than consolidated remuneration /emoluments/salary shall be admissible.
 12. Applicants already working elsewhere shall have to produce Relieving Certificate from their present employer before joining Institute.
 13. In case any information given or declaration by candidate is found to be false or if candidate has willfully suppressed any material information relevant to this appointment, he/she will be liable to be removed from service immediately at any stage and an action taken as deemed fit by appointing authority.
 14. The remuneration will be a fixed consolidated pay.
 15. Other terms and conditions of service which are not specifically mentioned herein will be governed by relevant rules and orders issued by the Institute from time to time.
