It is further stated that a citizen who desires to seek information under RTI Act, 2005 is required to submit, along with the application, a fee of Rs. 10/- (Rupees ten only). The fee may be paid through a demand draft, banker's cheque, or Indian Postal Order payable to the Director, LGBRIMH, Tezpur. The prescribed fee may also be paid in cash to the public authority against a proper receipt.

Applicants belonging to the Below Poverty Line (BPL) category are exempted from payment of the application fee; however, they must submit valid proof in support of their claim.

If any additional fee is required in connection with the RTI application, the same shall be payable through a demand draft, banker's cheque, or Indian Postal Order payable to the Director, LGBRIMH, Tezpur.
